**2017 BUDGET AND APPROPRIATION ORDINANCE**

AN ORDINANCE FOR THE BUDGET AND APPROPRIATION  
FOR THE GLENBARD FIRE PROTECTION DISTRICT  
DUPAGE COUNTY, ILLINOIS

WHEREAS, the Board of Trustees of the GLENBARD FIRE PROTECTION DISTRICT of DuPage County, Illinois, have met and considered anticipated expenditures and revenues for the fiscal year beginning July 1, 2017 and ending June 30, 2018.

Section I: NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE GLENBARD FIRE PROTECTION DISTRICT THAT THE FOLLOWING IS HEREBY ADOPTED AS THE BUDGET OF THE DISTRICT THAT INCLUDES THE DISTRICT'S ANTICIPATED INCOME AND CASH AND THE APPROPRIATIONS FOR THE DISTRICT'S GENERAL CORPORATE PURPOSES FOR THE FISCAL YEAR ABOVE-STATED AND SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER THIS DATE:

Section II: Each of the said sums appropriated and the aggregate thereof are deemed necessary by the Board of Trustees to defray the necessary expenses and liabilities of the District for general corporate purposes for the fiscal year ending June 30, 2018.

Section III: That the funds derived from sources other than the 2017 levy may be allocated by the Board of Trustees to such appropriations and in such amounts, respectively, as the Board may determine, within the limits of said appropriation respectively.

Section IV: That the unexpended balance of any item or items of any appropriation made by this Ordinance may be expended in making up any deficiency in any item or items in the same general appropriation made by this Ordinance.

Section V: That should any clause, sentence, paragraph, or part of this Ordinance be declared by a Court of competent jurisdiction to be invalid, such declaration shall not affect the validity of this Ordinance as a whole, or any part so declared invalid.

Section VI: This Ordinance shall be known as Ordinance No. 98.

Section VII: This Ordinance shall be in full force and effect from and after its passage, approval and publication in accordance with the law.
